"Executive Session" is a tool available to a Board of Directors to use in order to discuss matters of a sensitive nature or when it is desired to protect privacy and confidentiality. "Robert's Rules of Order" defines an executive session as a meeting or portion of a meeting whose proceedings are secret. Only members of the governing body are entitled to attend, but they may invite others to stay who have insight into the matters to be discussed. A motion is required to go into executive session, and a majority must approve it. During Executive Session, the proceedings are considered Confidential or Secret, any minutes that are recorded are kept separate from the overall meeting minutes, and must be approved only while in Executive Session, and members present are forbidden from discussion of these proceedings outside of the Executive Session members. There are no restrictions on actions that can be taken while in Executive Session, such as votes can be taken, etc. Those present must maintain the confidentiality of the discussion and anyone who violates that confidentiality is subject to disciplinary action. At the session's conclusion a motion is required and must have a majority approval to adjourn. After the Executive Session, if required, actions based upon the information presented can be discussed, voted upon, and included in the meeting minutes.

 - h. Junior Olympic Chair Clara Savannah is working with Tournament Director David Pereida on completion of the Fact Sheet.
 - i. Coaches committee chair James Johnson reported his pleasure with the discussions held at the recent coaches meeting. The coaches appreciated the meeting and the plan is to continue holding meetings approx. every couple of months.
